With more than 30 years of experience, George's comprehensive expertise encompasses the life span of a construction project, including planning, permitting, licensing, site acquisition, easements, development, design, engineering, bidding, procurement, contracts and contracting, risk management, and dispute resolution. George has represented owners, developers, contractors, subcontractors, designers, engineers, architects, suppliers, and other major vendors on projects of all types throughout Nevada. The majority of George's representations involve contractor-owner disputes, general contractor-subcontractor disputes, and construction defects.
