### PROFESSIONAL BACKGROUND

purpose entities, large corporations, financial institutions and banks, insurers and third party administrators, employers, and agencies created to act as receivers for failed businesses such as financial institutions and insurance companies.

### ***Bankruptcy, Insolvency & Restructuring***

Ms. Alstead's practice includes the representation of creditors and debtors in and out of bankruptcy court. She has represented a variety of clients from the loan default stage, to state court litigation, and then subsequently in bankruptcy after a bankruptcy case has been filed, adversary proceedings commenced, or a state court action removed to bankruptcy court.
