PROFESSIONAL BACKGROUND

Mr. Trachok currently serves as Chairman of Compliance for the German gaming Group, Gauselmann AG and has been responsible for obtaining gaming licenses for them in approximately 200 jurisdictions. He is also Chairman of the Global Compliance and Governance Committee for London-based IGT, obtaining gaming licenses in Nevada and other jurisdictions. In addition to his gaming work, Mr. Trachok also focuses on utility regulation. He worked as the lead outside regulatory counsel for NV Energy and handled all rate and resource planning cases for the Public Utilities Commission of Nevada from 2006 through 2013.

Mr. Trachok served 15 years as an adjunct professor at UNR, teaching construction law in the graduate construction management program (1988-2003). He was also an adjunct professor at the University of San Francisco School of Law from 2006 to 2013, teaching the Laws of International Trade. Mr. Trachok is currently an adjunct professor at the University of California, Berkeley School of Law, teaching the Law of International Trade and Gaming Law.
