Her pro bono assistance includes working with the Children’s Attorneys Project through the Legal Aid Center of Southern Nevada where she represents abused and neglected children placed in foster care.

Mackenzie graduated from the UNLV William S. Boyd School of Law, where she served as Notes Editor of the *Nevada Law Journal* and member of the Society of Advocates (Moot Court Team). Mackenzie was nominated by her law school peers to give the commencement speech alongside former Senate Majority Leader Harry Reid. She held clerkships with the Clark County Public Defender's Office and Justice Elissa F. Cadish of the Nevada Supreme Court.
